**TO WHOM IT MAY CONCERN,**

After moving from the UK, I began my rowing career in 2003 as an enthusiastic coxswain for Burnside High School in Christchurch. After developing my skills and passion for the sport I moved into a junior coaching position and eventually the Head Coach role at Burnside High School. Through committing to 5 years in such a small co-ed club, I was able to develop my resourcefulness, organisational skills and understand the relationship between culture and performance. Between 2010-2014 I worked as manager and Assistant coach at the Avon rowing club, as well as Vice-President of the University of Canterbury rowing club where I was responsible for overseeing the recruitment, retention and logistics of both programmes. I thoroughly enjoyed my time in these positions as they contributed to furthering my knowledge and skills in administrative management. Furthermore, I was able to work with, and learn from, some fantastic senior coaches. Since 2013 I have been Director of rowing and Head Coach at Rangī Ruru Girls' School.

After completing a Bachelor of Arts with a double major in English and Classics at the University of Canterbury, I began my teaching career in 2015 starting at a small decile 3 school, Hornby High School, and eventually to Rangī Ruru, where I am today. In 2019 I took a year away from teaching to complete a master's degree which focused on organisational leadership in the secondary educational sphere. I had a particular focus on decision making and examining pre-existing culture within established institutions. The transferable skills acquired through this process include communication, understanding the process behind decision making and the importance of being a team player in a collaborative environment.

My teaching and coaching philosophy embraces diversity and focuses on coaching the person as well as the athlete. My coaching experience can be defined by numerous podium finishes at national level across both sculling and sweep, in predominantly female events. I am especially proud of the increase of numbers at each of the organisations that I have been involved with and I use this as the key indicator that the rowers engage positively in a culture of hard work and enjoyment. If appointed to this committee I would look forward to working with the current group on issues around athlete retention and recruitment with a focus on what rowing looks like for the 21<sup>st</sup> century teenage learner and aiming to further strengthen the culture of secondary school rowing within New Zealand.
